-Enrollment – 150+ students added this year (increases especially in freshmen); over 300 students over last year; OHS beating projections of historical data – Positive for OHS: Increase of budget due to sections reimbursement due to growth
-Counselor – Budgeted counselor now paid for by district this year (funds added to LCFF and Title 1)
-Pride Time – Purpose: To support student achievement-30 minutes focused time 4 days a week/ Students with Ds or Fs-required to attend class at least 2 days of the week/Library offered as choice of activity/Data from teachers and students forthcoming/
*Student comments: Originally thought this wasn't needed, but now sees the helpfulness of it (Ocampo); After a week absence, found this useful to make up work (Paz); Helpful in getting work completed for Early College (Sanchez)
*Important Note: Pride Time did not extend the school day. It is part of instructional minutes that would have been absorbed within the periods. Day was extended due to later start time.
